

WARRANTY STATEMENT

Limited Lifetime Warranty

Multi-Appliance Ventilation System with Subduct Riser

AMPCO product components installed in a multi-appliance venting system application, which incorporates subduct risers for exhausting multiple appliances, are warranted to the original owner by Hart & Cooley, Inc. ("Manufacturer") to be free from defects in material and workmanship for the life of the product when properly connected to and included as a part of a code compliant ventilation system for laundry, bathroom and domestic kitchen hood exhaust, and installed and maintained in accordance with Manufacturer installation and maintenance instructions and appropriate building codes, under standard operating conditions for which the product is designed:

- (a) For products installed after January 1, 2008, for a period of Ten (10) years from original installation, Manufacturer will provide replacement product to the original owner for the product proven defective with a similar or like quantity of available AMPCO product
- (b) From the Eleventh (11) through Fifteenth (15) years Manufacturer will provide replacement product to the original owner at a cost of 75% off of the Manufacturer Suggested List Price in effect on the date the claim is received
- (c) At expiration of the Fifteen (15) year term, Manufacturer will provide replacement product to the original owner at a cost of 50% off of the Manufacturers Suggested List Price in effect on the date the claim is received

Manufacturer will, at its sole option, repair or replace parts and components found to be defective. Any defect arising from the improper installation, operation or maintenance of the product and system, and/or the connected appliance(s)/products, is not covered. The remedies set forth herein are Manufacturer's sole liability and customer's sole remedy for a breach of warranty hereunder.

Upon receipt of a written claim under this limited warranty and evidence of the date of purchase or installation, at Manufacturer's option and in Manufacturer's sole discretion, Manufacturer will either repair or replace the product with similar or like quantity of available AMPCO product per this warranty. Manufacturer reserves the right to inspect or investigate any warranty claims prior to determining whether to repair or replace a product. If, as determined by the Manufacturer, repair or replacement of the product is not commercially practicable or cannot be completed in a timely manner, Manufacturer may refund the prorated purchase price paid for the product upon verification by providing a copy of your invoice, receipt of bill of sale, based on the remaining warranty period.
